- -Recommends steps to initiate the development of the San Pedro Creek Art Program unique to Bexar County

#### ASSESSMENT PHASES

- Phase 1: Research, Learn, Assess (May June)
  - -Review existing documents and researching the history, culture and communities that frame San Pedro Creek
  - Research art programs and organizations in other places to assess and share best practices applicable to San Pedro Creek
  - -First visit to San Antonio



#### ASSESSMENT PHASES

- Phase 2: Present, Reflect, Refine (June July)
  - Take the information identified in the assessment and begin to develop options paired with benchmarking public art strategies and programs
  - -Visit to San Antonio to present options for the ways public art can engage the San Pedro Creek and adjacent communities
  - Discuss and recommend options for administrative structure, budgets, and project types based on our assessment and research
  - Develop a timeline and action steps to serve as a guide to assist local decision makers in establishing a public art program



#### ASSESSMENT PHASES

- Phase 3: Present a Strategy for the Public Art Program (July – August)
  - Return to San Antonio for two days to present the final strategy
  - -Feedback from this visit will be incorporated into the final deliverable



#### ASSESSMENT NEXT STEPS

- -Review scope of work and introduction to Art Advisory Committee on 5/16
- -Consultant team initial visit to SA: June 5-9
  - -Tour
  - -Design Team
  - -Elected officials
  - -Community leaders, art organizations, committees
  - -Ricardo Barreto at subcommittee meeting on June 9

#### PHASE 3

City of San Antonio proposed funding for trails anticipated approval by City Council on May 12

- -\$3.3 million
- -0.6 miles of trail

Linear Creekway Parks Advisory Board approved the recommendation on April 26

Recommendation presented to City Council in B Session on May 4
