


## Project Update – Phase 1.2 *Stream*


- Light fixtures and DMX controllers currently being installed

### San Pedro Creek Project: Phase 1.2 Houston Street to Nueva Street

- Installed portion of the slab for the flooring inside the AME footprint
- Installing below ground structural support for future shade structure
- Working on restroom foundation
- Installing tile in the area north of Commerce



### San Pedro Creek Project: Phase 1.3 Nueva Street to C. Chavez Blvd

- Nueva St. gatehouse exterior finish complete
- Stairs at Nueva St. complete
- Trellis adjacent to Nueva gatehouse installed and adjusting for ivy
- Tree planting on-going
- Graham St. sidewalks complete



## San Pedro Creek Project: Phase 2

Guadalupe Street to S. Alamo Street

- Guadalupe St. bridge sidewalks placed, installing railing
- Poured high paseo from Guadalupe to Culvert Park
- Ongoing work on Alamo restroom foundation



# San Pedro Creek Project: Phase 3

Railroad Bridge to Confluence w/ Apache Creek

- Ongoing excavation
- Installing footings for structural walls on east bank north and south of railroad bridge
- Building construction access roads
